Martin Berg, EIB

Martin Berg is a senior investment officer in the Infrastructure Funds and Climate Action Unit at the European Investment Bank (EIB) in Luxembourg where he focuses on investments in private equity funds related to clean infrastructure and the environment. In addition, he is also involved in innovative climate and environmental finance mechanisms, such as carbon bonds, securitisation of renewable energy assets, natural capital and payment for ecosystem services.

Prior to his current role, Martin coordinated the monetisation activities of the NER300 Initiative for the EIB, which raised over EUR 2 billion to fund carbon capture and storage demonstration projects and innovative renewable energy technologies.

Martin joined the EIB from Bank of America Merrill Lynch (BofAML) in London.

Prior to his time at BofAML, Martin worked at RNK Capital LLC, an environmental investment firm in New York, and the Organisation for Economic Co-operation and Development (OECD) in Paris.

Martin holds an MPA from Columbia University and an MA from the University of Bonn.

Nancy Saich, EIB



Nancy Saich is a chartered civil engineer who specialised early in her career in transport projects and more specifically in ports and coastal work. 25 years ago, she became involved in the discussions in the maritime engineering industry on the challenges of incorporating climate change impacts into the design guidance for maritime projects. This was the beginning of her close interest in climate change. After 13 years of work as a consulting engineer, she joined the European Investment Bank in 1998.

Nancy is one of the longest standing members of the Bank's Environmental Assessment Group, providing the Bank's Project Teams with due diligence support on environmental and climate matters on a wide range of projects funded by the Bank. She is also a founder member of the Bank's Inter-Directorate Climate Working Group. Following her move to the Bank's Environment, Climate and Social Office in 2011, Nancy has a specific role as EIB's Senior Adviser on Climate and Environment, and is responsible for leading the work on Climate Finance definitions and impact reporting.

Angela Falconer, Climate Policy Initiative

Dr. Angela Falconer is Associate Director in Climate Policy Initiative's Climate Finance program. Angela has led the production of several Landscapes of Climate Finance, at the global and national level in Indonesia, with the Ministry of Finance, and in Cote d'Ivoire, with the Ministry of Environment. She was heavily involved in CPI's Indonesia program in its early years, including roles advising the Government of Indonesia on national climate fund design and studies evaluating fiscal policies in the palm oil sector. She is now working with the Government of Kenya on

NDC financing. Angela has a particular interest in sustainable agriculture and forests.

Angela holds a PhD in the Science and Management of Climate Change from Ca' Foscari University of Venice.



Chizuru Aoki, Global Environment Facility

Chizuru Aoki is Lead Environmental Specialist for the Global Environment Facility (GEF). She leads GEF's strategy development for multiple Conventions for which the GEF serves as financial mechanism, including UNFCCC. She also manages the Special Climate Change Fund and the Least Developed Countries Fund.

She served as the GEF Coordinator for Climate Change Mitigation between 2011 and 2015. Prior to joining the GEF in 2010, she led one of the largest UN-led environmental interventions in post-conflict Iraq, with the United Nations Environment Programme.

Chizuru was a Fulbright Fellow at the Massachusetts Institute of Technology (MIT), where she received her Ph.D in Technology, Management and Policy.



Jay Koh, Lightsmith

Prior to founding Lightsmith in 2016, Mr. Koh was a Managing Director and Partner of Siguler Guff, a global alternative investment firm with over \$10 billion under management. Mr. Koh is also Founder & Chair of the Global Adaptation & Resilience Investment Working Group (GARI), a private sector, private investor-led initiative that was launched at Paris COP21. Mr. Koh serves on the Private Sector Advisory Group to the UN Green Climate Fund, the Board of the New York State Energy Research and Development Authority (NYSERDA), and the advisory committee to the NY Green Bank. He is also an adjunct professor at Columbia University's

School of International and Public Affairs. Mr. Koh is a member of the Council on Foreign Relations and holds an A.B. magna cum laude in Economics from Harvard College, a master's degree in Management from Oxford University and a J.D. from Yale Law School.



Suzi Tart, MARCO

Suzi's first COP experience was when the historic Paris Agreement took place. Then an advisor to the OECD on its COP21 communication strategy, she has since joined LGI's Innovation & Strategy Business Unit, where she works on projects related to climate change, low-carbon energy and urban transitions. For the past year, she has assessed the demand and supply gaps within Europe's climate services market, forecasting potential opportunities to propel market growth. Her experience includes working with UNCTAD and the Sustainable Stock Exchanges initiative to get securities regulators to promote improved environmental, social and governance disclosure among listed

companies. She holds a Master of International Development from the University of Pittsburgh, and a Master of Business Administration from the University of Geneva.



Mari Yoshitaka, Mitsubishi UFJ Morgan Stanley (MUMSS)

Mari Yoshitaka is Chief Consultant, Mitsubishi UFJ Morgan Stanley Securities. After working for an IT company and a U.S. investment bank, Mari obtained Master of Science from the Department of Natural Resources and Environment at the University of Michigan in Environmental Policy. She performed social impact studies for environmental projects in developing nations at IFC. Mari joined Mitsubishi UFJ Morgan Stanley Securities in 2000 for start-up of the Clean Energy Finance Division. Recently she is conducting advice and research on the field of Climate Finance

and ESG investment. In 2008 Mari has been appointed as project professor of Graduate School of Media and Governance, Keio University in Japan.
