### Overview

Project Name:	WARSAW MUNICIPAL INFRASTRUCTURE IV

Project Description:	The operation was structured as a Framework Loan to finance investments in five main sectors: transport and communications, health and social services, public spaces and environment, education and other urban infrastructure. The investments were implemented in the City of Warsaw, Poland and included a total of 135 projects.

### Summary of Environmental and Social Assessment at Completion

**EIB notes the following Environmental and Social performance and key outcomes at Project Completion.**

At appraisal, the Promoter was considered capable of managing the environmental and social issues related to the implementation of the programme and a series of undertakings were put in place. This was necessary due to the mixed composition of the programme which included projects in five different sectors.

Based on the information provided by the Promoter, out of the 135 projects only 6 required Environmental Impact Assessment (EIA) and public consultation:

- Swietokrzyska (C/OM/I/1/50A);
- Czerniakowska (C/OM/I/1/32);
- Nowolazurowa (C/OM/I/1/21A);
- Wawer Tunnel (C/OM/I/1/18);
- Siekierkowska (C/OM/I/1/2A); and
- Vistula Embankment Works (C/OM/III/3/2A).

The Promoter has provided the Non-Technical Summaries (NTSs) for these projects published in accordance with Bank procedures<sup>2</sup>.

The Promoter did not report any other projects of the investment programme as requiring from the Competent Authorities an EIA Report or an Appropriate Assessment in compliance with the Habitats Directive.

The investment had a large component (approximately 50%) dedicated to the health and education sectors in addition to public spaces and environmental projects. It is expected that these cumulative investments had social benefits for the city's population.
