### Summary of Environmental and Social Assessment at Completion

**EIB notes the following Environmental and Social performance and key outcomes at Project Completion.**

The project was appraised in 2016, and an Environmental and Social Data Sheet was prepared

The project was a framework loan with a number of infrastructure and social facilities. At the time of appraisal, there were 11 known schemes, covering following sectors:

- Urban road safety schemes – construction and modernisation of roads and road safety measures,
- Educational facilities – modernisation and expansion of schools,
- Municipal investments – revitalisation of city historical sites, construction of recreation facilities (swimming pool), construction of animals care facilities (shelter and Zoo), creation of the museum
- Social facilities – construction of houses for teenagers and families,
- Sustainable transport – construction and modernisation the tram lines, bus stations and bus lanes, electric buses purchase.

The total loan amount was fully allocated to the schemes and disbursed successfully. 13 schemes were below EUR 25 million (small projects), 3 were between EUR 25 – 50 million (medium size projects), one scheme at outturn was marginally above EUR 50 million, at allocation was classified as medium size scheme.

The construction and modernisation of tram infrastructure and the urban road projects fall under Annex II of the EIA Directive 2011/92/EU and hence required a screening decision from the Competent Authority.

At outturn, 6 out of initially planned schemes were allocated, together with 11 new schemes,

The construction and modernisation of tram infrastructure and the urban road projects as well as new animals' shelter construction fall under Annex II of the EIA Directive 2011/92/EU and hence required a screening decision from the Competent Authority.

- Scheme 1 (Reconstruction of the road viaducts along Krzywoustego street over Inflancka and Chartowo streets.) was screened in March 2012, and the competent Authority issued two environmental permits in September 2012, with amendments in 2014.
- Scheme 2 was screened out by competent authority in October 2016.
- Scheme 5 was screened out by competent authority in February 2017.
- Scheme 6 was split for several sections, all sections were screened out by competent authority in November 2013, August and December 2016 and February 2017 respectively.
- Scheme 7 was screened out by competent authority in May 2016.

No investment required an impact assessment in line with the Habitats / Birds Directive
