# Summary of Environmental and Social Assessment, including key issues and overall conclusion and recommendation

The Council Directive 2011/92/EU on Environmental Impact Assessment (EIA) does not specifically mention education activities. However, in a case of urban development, Annex II of the EIA Directive could have applied. Strategic environmental assessment (SEA) was conducted. EIA was screened out as not required. Overall environmental and social assessment is acceptable (B), with possible minor negative residual impacts. The Promoter is conscious of environmental issues and the mitigation measures regarding have been identified.

#### **Environmental and Social Assessment**

#### **Environmental Assessment**

The project site is situated in existing in urban area, close to the city centre. The Bank has been informed in a written form by the Promoter that the project was screened out by local authorities regarding EIA. However, delivery of the copy of decision of the relevant authorities in that respect will be the disbursement condition, unless the document is obtained earlier. The core of the campus area will be closed for car and bus traffic. The new campus will be connected to the city centre and suburbs of Dublin by public transport (busses, railway). The development is part of the urban regeneration and rejuvenation of the Grangegorman district, previously hosting premises of the psychiatric hospital and other facilities, previously with limited access for the public. Strategic environmental assessment (SEA) was conducted regarding the Grangegorman Strategic Plan 2011. The currently presented project will include construction of the Central Quad hosting College of Science and Health and the East Quad with College of Arts. A number of public agencies, including the Dublin City Council, have been consulted in the SEA process. The Promoter is conscious of environmental issues.
