### **Environmental and Social Assessment**

### **Environmental Assessment**

The RDI activities included in the project do not fall under any Annexes of the EIA Directive; moreover, the research and development activities will be carried out in existing facilities already authorised that will not change their scope due to the project. As such, the project does not require an Environmental Impact Assessment as per Directive 2011/92/EU as amended.

The residual project risks are deemed low. Energy and resources saving are key drivers for the promoter's RDI; lower energy consumption, better utilisation of resources translate into reduced operating costs and thus into a clear economic benefit for the final customer, namely who purchases and operates the production lines. These aspects are key drivers for competitiveness as energy and raw material costs represent the biggest part of the manufacturing cost.

In total, the RDI project, if successful, will further improve the promoter's product environmental performance. Additional environmental benefits derive from the fact that the promoter adopts the same quality standards to all its product offering, independently from the markets where this machinery is sold; in light of the main markets the promoter is addressing, e.g. China, India and other emerging economies, the new equipment developed as consequence of the project will contribute to set also there the benchmark in terms of environmental performance.
