Summary of Environmental and Social Assessment at Completion

EIB notes the following key Environmental and Social outcomes at Project Completion.

The measures consisted of investments in drinking water treatment and distribution, as well as wastewater collection and treatment infrastructure for thirteen agglomerations/water supply zones in the County of Botosani in the eastern part of Romania on the border with Moldova. The County is on an elevated plain, between the valleys of the Siret River, the Prut River and its tributary, the Jijia River. The project contributes to the protection of water bodies by implementing works that treat wastewater to the standards required by the EU Directive for Urban Waste Water Treatment 91/271 EEC and by ensuring an efficient and sustainable use of water resources. In addition, the project contributes to the compliance of Romania with the EU Drinking Water Directive 98/83/EC.

The project partially contributed to: (i) Improve the environmental situation in Botosani County - and reduce the health risk for the population living in the area due to the extension of sewer networks (ii) improve the water quality in the recipient rivers and (iii) reduce the pollution of soil & subsoil and groundwater.

The Project included provisions for the establishment of strategies and action plans for sludge and industrial wastewater management, the latter with a view to safeguarding the operation of wastewater treatment processes and safe sludge disposal. These action plans were developed together with the Feasibility studies.

The Project is part of the SOPs (Sectoral Operational Programmes) that fall under SEA¹ Directive and the procedure was undertaken accordingly.

The Project is covered by Annex II of the EIA Directive 85/337/EEC as amended by Directives 97/11/EC and 2003/35/EC. Negative Screening Decisions were issued for all project components: Botosani no. 3389/2011, Dorohoi no. 3390/2011, Flamânzi no. 3388/2011, Vorona no. 3387/2011, Stefanesti no. 10324/2010, Saveni no.10323/2010. by the regional environmental protection agency (EPA-Botosani).

The negative screening decisions were made available to the public through notices in newspapers (from EPA Botosani and the Promoter S.C. NOVA APASERV S.A), and announcements posted at the EPA Botosani, Local Councils and Promoter locations. No remark from the public was registered.

The Relevant authorities confirmed that the Project did not have any significant effect on Natura 2000 sites.

EIB is of the opinion, based on reports from the promoter that Phase 1 of the Project has been implemented in line with EIB Environmental and Social Standards, applicable at the time of appraisal.
