### Decisions taken by the EFSI Investment Committee in April 2019

Investment Committee decisions approving the availability of the EU guarantee for EIB operations are made publicly available, except for projects subject to a confidentiality agreement between the EIB and the promoters.

In line with article 30 of the EFSI Agreement and the Transparency Policy of the Bank, Investment Committee decisions for such cases will be disclosed at a later stage by including them in a list of Investment Committee decisions taken throughout the year and published, in general, twice a year. This is after the projects have been signed or if these projects are not subject to a confidentiality agreement between the EIB and the promoters anymore.

The Investment Committee approved the availability of the EFSI portfolio guarantee for the following EIB operations:

#### CESKA SME AND MID-CAP MEZZANINE ABS (Czech Republic)

A guarantee of EUR 110m for the mezzanine tranche of a synthetic securitisation of an SME loan portfolio originated by Ceska Sporitelna bank.

#### ALFASIGMA INNOVATIVE DRUGS RDI (Italy)

A loan of EUR 100m to finance the promoter's research activities including clinical and regulatory development for the development of innovative drugs in the areas of gastroenterology, vascular medicine and rheumatology over the period 2019 - 2022

#### FRENCH OFFSHORE ROUND 1 - SAINT NAZAIRE & FECAMP (France)

A loan to finance the design, building and operating of two offshore windfarms.

#### PECS WATER AND WASTEWATER REHABILITATION (Hungary)

A loan of EUR 17.41m to finance the Financing of the rehabilitation of water and wastewater utilities in Pécs and its environment through Tettye FH, the municipal water and wastewater operator
