Investment Committee decisions approving the use of the EU guarantee for EIB operations are made publicly available, except for projects subject to a confidentiality agreement between the EIB and the promoters.

In line with article 30 of the EFSI Agreement and the Transparency Policy of the Bank, Investment Committee decisions in 2018-2020 for such cases, which have not yet been disclosed as of 8 March 2023 are published below. This is after the projects have been signed or if these projects are not subject to a confidentiality agreement between the EIB and the promoters anymore.

CRONOS LOGEMENT INTERMEDIAIRE (France)

A loan of EUR 205m ton finance construction programme of 2200 affordable housing in the region Ile-de-France in France by the private entity FONCIERE CRONOS founded by IN'LI.

DB SPAIN ENHANCED SUPPORT FOR SMES & MIDCAPS (Spain)

A funded risk participation of EUR 150m to support new SME and Midcap lending in Spain with Deutsche Bank Spain.
