REVIEW YOUR CONTRACTUAL DOCUMENTATION FOR ANY SPECIFIC ADDITIONAL REQUIREMENTS (SUCH AS THE USE OF THE EU FLAG IN CERTAIN INSTANCES)

**Additional note for EIB Global operations supported by EU Funding:** where EIB Group financing supports operations outside the European Union, different EU visibility requirements may apply. Clients may be asked to ensure that EU support is visibly acknowledged during implementation, for example via the display of the EU flag on financed infrastructure (where relevant and feasible) and/or tailored communication activities. These arrangements are typically coordinated with the European Commission and EU Delegations, and clients will be informed of any specific requirements applicable to their operation.

# ANNEX

## A) OPERATIONS WITH A PHYSICAL SITE

### TYPICAL OPERATION OR PROJECT TYPE

- \* INFRASTRUCTURE AND RENEWABLES (TRANSPORT, ENERGY GENERATION, GRIDS, PORTS, AIRPORTS)
- \* MANUFACTURING AND INDUSTRIAL FACILITIES (NEW PLANT, EXPANSION, EQUIPMENT INSTALLATION)
- \* SOCIAL INFRASTRUCTURE (SCHOOLS, HOSPITALS, HOUSING)
- \* MUNICIPAL OR URBAN PROJECTS (WATER PLANT, WASTEWATER PLANT, SOLID WASTE FACILITY, DEPOT, TRANSPORT HUBS)

### POTENTIAL VISIBILITY (TO BE AGREED WITH THE CLIENT OR PROMOTER)

- \* START OF WORKS: BILLBOARD OR SITE SIGNAGE
- \* AT COMPLETION: PLAQUE
- \* DIGITAL: WEBSITE OR PROJECT PAGE MENTION OF THE EIB GROUP LOGO (WHERE RELEVANT)
- \* MEDIA AND SOCIAL: PRESS RELEASE AND/OR SOCIAL MEDIA CONTENT (AS RELEVANT)
- \* EVENTS: INAUGURATION OR MILESTONE CEREMONY (AS RELEVANT)

## B) NON-PHYSICAL OPERATIONS

(NO CONSTRUCTION SITE OR NO PUBLIC-FACING WORKS SITE)

### TYPICAL OPERATION OR PROJECT TYPE

- \* CORPORATE FINANCE WITHOUT A PROJECT SITE (GENERAL CORPORATE PURPOSES, WORKING CAPITAL, LIQUIDITY, BALANCE-SHEET SUPPORT)
- \* DIGITAL, RESEARCH AND DEVELOPMENT, INNOVATION, SERVICES (WHERE THERE IS NO CONSTRUCTION SITE OR SUITABLE PUBLIC-FACING LOCATION)

### POTENTIAL VISIBILITY (TO BE AGREED WITH THE CLIENT OR PROMOTER)

- \* DIGITAL: WEBSITE MENTION, DIGITAL BANNER, "SUPPORTED BY THE EUROPEAN INVESTMENT BANK" STATEMENT, CASE STUDY, PROJECT PAGE
- \* MEDIA AND SOCIAL: PRESS RELEASE AND/OR SOCIAL MEDIA CONTENT (SIGNATURE, MILESTONE, IMPACT STORY)
- \* EVENTS: LAUNCH, MILESTONE ANNOUNCEMENT (AS RELEVANT)

## C) INTERMEDIATED OPERATIONS

(VIA BANKS AND OTHER FINANCIAL INTERMEDIARIES)

### TYPICAL OPERATION OR PROJECT TYPE

- \* CREDIT LINES, LEASING, GUARANTEES, RISK-SHARING DELIVERED THROUGH BANKS OR OTHER FINANCIAL INTERMEDIARIES
- \* PROGRAMMES IMPLEMENTED VIA NATIONAL PROMOTIONAL BANKS OR SIMILAR PARTNER INSTITUTIONS
- \* FUNDS (WHERE THE EIB PARTICIPATES ALONGSIDE OTHER INVESTORS)

### POTENTIAL VISIBILITY

(TO BE AGREED WITH THE INTERMEDIARY AND, WHERE FEASIBLE, REFLECTED DOWNSTREAM)

- \* INTERMEDIARY-LEVEL VISIBILITY: INTERMEDIARY WEBSITE MENTION, PRODUCT PAGE, DIGITAL BANNER, NEWSLETTERS, "SUPPORTED BY THE EUROPEAN INVESTMENT BANK" MESSAGING
- \* FINAL BENEFICIARY VISIBILITY (WHERE FEASIBLE AND TO BE DISCUSSED): DIGITAL MENTION AND/OR PHYSICAL SIGNAGE ONLY WHEN SUB-PROJECTS HAVE A PHYSICAL SITE AND THE CONTRACTUAL/MONITORING SETUP ALLOWS IT
- \* MEDIA AND SOCIAL: JOINT COMMUNICATIONS AROUND LAUNCH OF THE PRODUCT/CREDIT LINE, MILESTONES, IMPACT STORIES
- \* EVENTS: LAUNCH EVENT, STAKEHOLDER EVENTS, SELECTED BENEFICIARY SITE VISITS (WHERE FEASIBLE)

## D) EQUITY, QUASI-EQUITY OR FUND INVESTMENTS

### TYPICAL OPERATION OR PROJECT TYPE

- \* EQUITY OR QUASI-EQUITY INVESTMENTS
- \* FUND INVESTMENTS (VENTURE CAPITAL, PRIVATE EQUITY, INFRASTRUCTURE FUNDS)

### POTENTIAL VISIBILITY (TO BE AGREED ON A CASE-BY-CASE BASIS)

- \* DIGITAL: MENTION ON FUND/PARTNER WEBSITES AND RELEVANT PAGES
- \* MEDIA AND SOCIAL: PRESS RELEASE AND/OR SOCIAL CONTENT AT KEY MILESTONES (INVESTMENT, FIRST CLOSING, DEPLOYMENT MILESTONE)
- \* EVENTS: LAUNCH/SIGNATURE MOMENTS (AS RELEVANT)

## E) GUARANTEES, RISK SHARING OR SECURITISATION-TYPE SUPPORT (TYPICALLY NO WORKS TRIGGER)

### TYPICAL OPERATION OR PROJECT TYPE

- \* GUARANTEE INSTRUMENTS, RISK-SHARING FACILITIES, SECURITISATION SUPPORT

**POTENTIAL VISIBILITY** (TO BE AGREED CASE-BY-CASE)

- \* DIGITAL: INSTITUTIONAL/PARTNER WEBSITE MENTION OF EIB GROUP LOGO, PRODUCT PAGE MESSAGING
- \* MEDIA AND SOCIAL: JOINT COMMUNICATIONS AT LAUNCH AND MILESTONES (AS RELEVANT)
- \* EVENTS: LAUNCH OR STAKEHOLDER EVENTS

**F) ADVISORY OR TECHNICAL ASSISTANCE (NO WORKS TRIGGER)**

**TYPICAL OPERATION OR PROJECT TYPE**

- \* ADVISORY ASSIGNMENTS, TECHNICAL ASSISTANCE, CAPACITY-BUILDING SUPPORT

**POTENTIAL VISIBILITY** (TO BE AGREED ON A CASE-BY-CASE BASIS)

- \* DIGITAL: ADVISORY PAGE MENTION, PROJECT FACTSHEET
- \* MEDIA AND SOCIAL: COMMUNICATIONS AROUND OUTPUTS AND MILESTONES (AS APPROPRIATE)
- \* EVENTS: AS RELEVANT
